Special Terms and conditions;

- **Please submit the bid on COMSATS University Islamabad, Lahore Campus's prescribed BoQs and clearly mention the quoted model / brands with complete terms and conditions signed, stamped, otherwise your bid (s) may be rejected.**
- **Chemicals which require special conditions e.g. low temperature etc. must be provided as such otherwise their delivery will not be accepted.**
- **The packing should contain a label showing verifiable/traceable catalogue / lot number of Chemicals.**
- **Certificate of Analysis must be Online Verified from the Original Manufacturer/Principal Website.**
- **Under no circumstances should re-packed chemicals be provided.**
- Purchase / work order shall be awarded on **Item Wise** basis.
- **Multiple prices of an item may lead to the rejection of item/bid.**

1. **Any addition, deletion or modification of any clause of the procurement terms & conditions of COMSATS University Islamabad, Lahore Campus by any vendor will not be acceptable and may lead to rejection of the bid.**

3. The exact completion / delivery time from the date of the purchase / work order will be **20 days**. The handing over / completion time for this contract is of critical importance.

5. The quotation should be submitted in a sealed envelope.

Payment will be made on submission of Invoice in the name of “COMSATS University Islamabad, Lahore Campus” with a copy of delivery challan (s) after the complete order has been supplied, inspected and accepted which includes delivery and installation, and COMSATS Lahore acceptance / inspection thereof.
- 8. All prices should be quoted on F.O.R (Pak Rupees) and **valid for at least 40 days.**
- 9. In case of any dispute or grievance, the matter shall be addressed as per PPRA rules.
- 10. **If the vendor fails to deliver the goods / services to COMSATS University Islamabad (CUI), Lahore Campus within the given deadline, any of the following can be opted by CUI Lahore campus on the recommendation of the end user and approval of the authority;**
