2. **Please submit the bid on COMSATS University Islamabad, Lahore Campus's prescribed BoQs and clearly mention the quoted model / brands with complete terms and conditions signed, stamped, otherwise your bid (s) may be rejected.**
3. **Multiple rates of an item may also lead to the rejection of bid / item.**
4. **Purchase order shall be awarded to successful bidder (s) on Item Wise basis as mentioned in BoQs.**
5. **Vendors are strongly advised to visit CUI-Lahore Campus and inspect sample of all items from IRCBM Department of CUI-Lahore Campus before quoting any item / brand / model to avoid quality, specification and compatibility issues which may lead to rejection of bid.**
