- 6. Only vendors with relevant expertise / setup in the printing services shall be considered.
- 7. Part / Advance payments is not allowed.

The exact completion/delivery time from the date of the purchase / work order will be 10 days (After the finalization of Design) for Printing Items & 15 Days for Souvenirs Items and Advertisement items should be installed before one day of event shall be communicated through purchase order well before in time (Standee should be provided within 05 days after the finalization of design). - 9. Your bid proposal should be inclusive of freight and all other taxes and to be delivered at CUI, Lahore Campus's premises.
- 10. After opening of bids, CUI, Lahore Campus will examine the bids for completeness as per tender document.

- 15. The bid form (BoQs) must be duly filled in, stamped and signed by the authorized representative of the bidder.
- 16. If the vendor fails to deliver the goods / services to CUI-Lahore Campus in time then the penalty will be charged as under:
 - a. 1% per day of the invoice price for 5 working days.
 - b. 2% per day of the invoice price for further 5 working days.
 - c. If the vendor fails to deliver the goods / services during the extended period then the purchase / work order may be cancelled, earnest money and payment may be forfeited.
