A. <u>TERMS AND CONDITIONS</u>

- 1. All pages of bidding documents are mandatory to be signed / stamped, meaning thereby bidder agrees to our terms & conditions mentioned herein, failing which the bid may be rejected.
- 2. Any addition, deletion or modification of any clause of the procurement terms & conditions/ BoQs of CUI Lahore Campus by any vendor will not be acceptable and may lead to rejection of the bid.
- 3. Only registered Suppliers, who are on Active Taxpayers List (ATL) of FBR, are eligible to participate in tender.
- 4. The contract will be executed and handed over in satisfactory conditions up to the entire satisfaction of CUI, Lahore Campus.
- 5. Documents along with Pay Order / Demand Draft amounting to <u>Rs. 1,000/-</u> as a tender document fee (Non-Refundable) shall be submitted in favor of COMSATS University Islamabad (CUI), Lahore Campus to the address given below. No bid will be accepted without tender documents' fee.
- 6. Part / Advance payments is not allowed.
- 7. The exact completion/delivery time for is 60 Days (starting from the date of LC Opening). The handing over / completion time for this contract is of critical importance.
- 8. The bid proposal must be quoted inclusive of all freight and packing charges in C&F and to be delivered at Lahore Airport. CUI Lahore Campus shall open the direct LC in favor of Original Manufacturer / Principal and shall also clear the shipment from Custom Authorities.
- 9. After opening of bids, CUI Lahore Campus will examine the bids for completeness as per tender document.
- **10.** Purchase order (s) will be awarded to the successful bidder as per the evaluation criteria on the basis Item wise as mentioned in BoQs.
- 11. The bid should be submitted in a sealed envelope up to <u>February 06, 2019</u> on or before <u>1400hrs</u> and will be opened on the same date <u>at 1430hrs</u> in the presence of available bidders.
- 12. CUI Lahore Campus, will follow the PPRA rule of single stage two envelope procedure;
 - i. The bid shall comprise a single package containing**two separate envelopes**. Each envelope shall contain separately the <u>financial proposal</u> and the <u>technical proposal</u>;
 - ii. The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion;

- iii. Initially, only the envelope marked <u>"TECHNICAL PROPOSAL"</u> shall be opened;
- iv. The envelope marked as<u>"FINANCIAL PROPOSAL</u>"shall be retained in the custody of the procuring agency without being opened;
- v. The procuring agency shall evaluate the technical proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not conform to the specified requirements;
- vi. During the technical evaluation no **amendments** in the technical proposal shall be permitted;
- vii. The financial proposals of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance;
- viii. After the evaluation and approval of the technical proposal the procuring agency, shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically nonresponsive shall be returned un-opened to the respective bidders;
- ix. The bid found to be the lowest evaluated bid shall be accepted.
- **13.** The envelope should be marked as under;

- 14. The envelope shall also bear the word "CONFIDENTIAL" and the Title of procurement of "Laptop Computer for COMSATS University Islamabad (CUI)-Lahore".
- **15.** The bid form (BoQs) must be duly filled in, stamped and signed by the authorized representative of the bidder.
- **16.** If the vendor fails to deliver the goods / services to CUI Lahore Campus in time then the penalty will be charged as under:
 - a. 1% per day of the invoice price for 5 working days.
 - b. 2% per day of the invoice price for further 5 working days.
 - c. If the vendor fails to deliver the goods / services during the extended period then the purchase / work order may be cancelled, earnest money and payment may be forfeited.
- 17. If the delivered goods / services are not according to the required quality standards / specifications, the same shall be liable to be rejected after inspection. The vendor would be required to supply as per requirements mentioned in our BoQs, otherwise the purchase / work order will be cancelled after due date with confiscation of earnest money.
- **18.** Deduction of Income Tax and any other tax will be deducted at source according to Government prevailing rules.
- **19.** All prices should be valid for at least <u>120 days.</u> Withdrawal or any modification of the original offer within the validity period shall entitle CUI Lahore Campus to forfeit the earnest money in favor of the CUI Lahore Campus and / or put a ban on such vendor participation in CUI tenders / works.

- **20.** It is the sole responsibility of the agent / supplier / manufacturer to comply with the applicable laws, be national or international.
- 21. In case of any dispute or grievance, the matter shall be addressed as per PPRA rules.
- 22. The CUI Lahore Campus reserves the right to modify the quantities of goods / services (may be increased or decreased) at any time before the award of purchase / work order. However, initial order shall be issued for 100 or more Laptops in either category (i.e. Core i-5 or Core-i7) depending upon the demand received from CUI Lahore Campus employees in a respective category.
- 23. A rate contract will be signed with the technically and financially qualified bidder for a period of one year. Additional orders of 10 or more laptops may be placed during the contract period of one year, as per need basis.
- 24. The Successful/lowest bidder is required to submit the 05% of the total value of Purchase Order as a retention money in form of Call Deposit Receipt/ Local Bank Guarantee with the validity of Warranty Time Period i.e. (<u>Three Year Onsite</u>) in favor of COMSATS University Islamabad (CUI), Lahore Campus and it will be released after the completion of warranty period, which start from the date of completion of work / installation.
- 25. The bidder is required to furnish in form of <u>Bank deposit/ CDR / Pay order equivalent to 2% of the total Bid price as Earnest Money crossed in favor of "COMSATS University Islamabad (CUI), Lahore Campus".</u> Any bid not accompanied by Earnest Money shall be rejected without any right of appeal.
- 26. CUI Lahore Campus reserves the rights to reject the bid if;
 - i. Received without earnest money
 - ii. Received later than the date and time fixed for tender submission
 - iii. The tender is unsigned/ unstamped
 - iv. The offer is ambiguous
 - v. The offer is conditional
 - vi. The offer is from a firm, which is black listed by any Govt. Office.
 - vii. The offer is received by telephone/telex/fax/telegram.
 - viii. Any unsigned / ambiguous erasing, cutting / overwriting etc. is made.
