- 3. The auction documents should be submitted up to <u>Tuesday/April 29, 2025</u> on or before <u>11:00hrs</u> and the <u>open auction</u> will be held on the same date at <u>11:30hrs</u>, at COMSATS University Islamabad Lahore Campus.

Terms and Conditions of Auction

- 1. The <u>Wheat Straw (Toori/Bhoosa)</u> may be seen / visited at COMSATS University Islamabad Lahore Campus on any working day during office hrs.
- 2. The minimum bidding price is Rs. 1800/-per Acre exclusive of all taxes (One thousand & eight hundred only)
- 3. Your quotation price should be exclusive of all taxes. Taxes on gross/bidding amount will be applicable 10% to Filer and 20% to Non-Filer
- 4. Wheat Straw (Toori/Bhoosa) will be auctioned on "AS IS AND WHERE IS BASIS"
- 5. The highest bidder will have to <u>deposit 30% amount</u> of total bid at COMSATS University Islamabad Lahore Campus HBL Branch <u>on the spot</u> by getting Challan Form from the Accounts Section and the balance amount will have to be **deposited within 03 days** on acceptance of the highest bid by the Competent authority i.e. (subject to the approval of competent authority) and then handing/taking over of the items/ materials will be done.
- 6. If the Vendor fails to deposit the remaining amount within stipulated time period as mentioned in clause # 5, his already submitted 30% amount shall be forfeited.
- 7. All prices should be valid for at least <u>60 days</u> withdrawal or any modification of the original offer within the validity period shall entitle CUI to forfeit the earnest money in favor of the CUI Lahore.
