A. <u>GENERAL TERMS AND CONDITIONS</u>

- 1. All pages of bidding documents are mandatory to be signed / stamped, meaning thereby bidder agrees to our terms & conditions mentioned herein, failing which the bid may be rejected.
- 2. Any addition, deletion or modification of any clause of the procurement terms & conditions/BoQs of CUI-Lahore Campus by any vendor will not be acceptable and may lead to rejection of the bid.
- 3. Only registered Suppliers, who are on Active Taxpayers List (ATL) of (GST & Income Tax) of FBR, are eligible to participate in tender.
- 4. The contract will be executed and handed over in satisfactory conditions up to the entire satisfaction of COMSATS University Islamabad, Lahore Campus.
- Documents along with Pay Order / Demand Draft amounting to <u>Rs. 500/-</u> as a tender documents fee (Non-Refundable) shall be submitted in favor of COMSATS University Islamabad, Lahore Campus to the address given below. No bid will be accepted without tender documents' fee.
- 6. Part / Advance payments is not allowed.
- 7. <u>Purchase / Work / Services Order shall be issued as and when required services within contract period</u> (One Year).
- 8. Your bid proposal should be inclusive of freight and all other taxes delivered at COMSATS University Islamabad, Lahore Campus's premises.
- 9. After opening of bids, COMSATS University Islamabad, Lahore Campus will examine the bids for completeness as per tender document.
- 10. Purchase / Work order (s) will be awarded to the lowest or technically recommended bidder (s) on the basis of item wise / subtotal wise / grand total wise according to the nature of BoQs.
- 11. The bid should be submitted in a sealed envelope up to <u>July 08, 2020</u> on or before <u>1100hrs</u> and will be opened on the same date <u>at 1130hrs</u> in the presence of available bidders.

14. The bid form (BoQs) must be duly filled in, stamped and signed by the authorized representative of the bidder.

15. If the vendor fails to deliver the goods / services to COMSATS University Islamabad (CUI), Lahore Campus within the given deadline, any of the following can be opted by CUI Lahore campus on the recommendation of the end user and approval of the authority;

- a. An extension in the delivery period may be granted in case a valid reason/justification with necessary documentary evidence is provided by the vendor supporting the reason for delay.
- b. A penalty upto 10% of the invoice value may be charged.
- c. Purchase order may be cancelled along with confiscation of earnest money if the vendor fails to deliver the goods / services after the initial or extended delivery time, as the case may be.
- 16. If the delivered goods / services are not according to the required quality standards / specifications, the same shall be liable to be rejected after inspection. The vendor would be required to supply as per requirements mentioned in our BoQs, otherwise the purchase / work order will be cancelled after due date with confiscation of earnest money.
- 17. Deduction of Income Tax and any other tax will be deducted at source according to Government prevailing rules.
- 18. General:

- 4. Payment shall be released on half year basis on submission of invoices of both scheduled and un scheduled services.
- 5. The contractor will not be responsible for repair and maintenance if the system is damaged with earthquake, fire and unreasonable use.
- 6. All the equipment of exchange system is covered under the agreement, there shall be no additional charges for the cost of Engineers hours and spare parts for any routine preventive Maintenance and any on call repair that may be necessary.
- 7. COMSATS University Islamabad-Lahore Campus shall reserve the right to terminate the agreement any time through a written advance notice of 30 days to the company. In such a case, the amount paid to company will be reimbursed to the customer, proportionally for the remaining period.

Company's Responsibilities:

- 1. Maintenance will include scheduled and unscheduled service, on all remedial maintenance based on the specific needs of the equipment.
- 2. The company shall provide scheduled maintenance on quarterly basis i.e 04 times during the year of agreement.
- 3. Maintenance will include testing running diagnostics, cleaning, adjustment and replacement of parts as and when necessary.
- 4. Company shall endeavor to respond to calls within <u>04</u> working hours, if the complaint is lodged during regular business hours and days the response time will depend on the availability of engineer. If the problem is not resolved within 48 hours <u>2 days</u> thereafter, company will provide temporary arrangement as backup unit.
- 5. Services rendered under this agreement will be performed at COMSATS University Islamabad-Lahore Campus premises unless in the opinion of the company in which case the work will be performed in their workshop.
- 6. Maintenance must include whole equipment of exchange system.
