- 3. Supporting literature of the quoted model must be attached for verification & technical evaluation of the required specification by the technical committee. In case of any clash is found between the quoted model and the supported literature may lead to rejection of bid.

### Special Terms and conditions;

- 1. <u>Bidders are requested to quote genuine / quality products without compromising on quality. The supplied</u> products shall be inspected by our technical experts with respect to BoQs requirements and quality <u>standards.</u>
- 2. <u>Please submit the bid on COMSATS University Islamabad, Lahore Campus's prescribed BoQs and clearly</u> mention the quoted model / brands with complete terms and conditions signed, stamped, otherwise your <u>bid (s) may be rejected.</u>
- 3. <u>Multiple rates of an item may also lead to the rejection of bid / item.</u>
