- 3. Please submit the bid on COMSATS University Islamabad, Lahore Campus's prescribed BoQs and clearly mention the quoted model / brands / manufacturing origin with complete terms and conditions signed, stamped, otherwise your bid (s) may be rejected.
- 4. Multiple rates of an item may also lead to the rejection of bid / item.
- 5. Purchase / work order shall be awarded to successful bidder (s) for Part wise on turnkey / sub total amount basis.
