In case of any clash is found between the brand/ model / make and the supported literature may lead to rejection of bid.

1. Bidders are requested to quote genuine / quality products without compromising on quality. The supplied products shall be inspected by our technical experts with respect to BoQs requirements and quality standards.

- 2. Please submit the bid on COMSATS University Islamabad, Lahore Campus's prescribed BoQs and clearly mention the quoted model / brands / make with complete terms and conditions signed, stamped, otherwise your bid (s) may be rejected.
- 3. Multiple rates of an item may also lead to the rejection of bid / item.
- 4. Purchase / work order shall be awarded to successful bidder (s) on Item Wise Basis.
- 5. Chemicals which require special conditions e.g. low temperature etc. must be provided as such otherwise their delivery will not be accepted.
- 6. Under no circumstances should re-packed chemicals be provided.
