- 2. Please submit the bid on COMSATS University Islamabad, Lahore Campus's prescribed BoQs and clearly mention the quoted model / brands / make with complete terms and conditions signed, stamped, otherwise your bid (s) may be rejected.
- 3. Multiple rates of an item may also lead to the rejection of bid / item.
- 4. Purchase / work order shall be awarded to successful bidder (s) on Sub Total (Part Wise) as mentioned in BoOs.
- 5. Vendor is required to make ensure the availability of the item in the local market before quoting them.

Payment will be made on submission of Invoice in the name of "COMSATS University Islamabad, Lahore Campus" with a copy of delivery challan (s) after the complete order has been supplied, inspected and accepted which includes delivery and installation, and COMSATS Lahore acceptance / inspection thereof.
- 9. All prices should be quoted on F.O.R (Pak Rupees) and valid for at least 60 days.
