- 1. <u>Bidders are requested to quote genuine / quality products without compromising on quality. The supplied</u> products shall be inspected by our technical experts with respect to BoQs requirements and quality <u>standards.</u>
- 2. Bidders are required to visit the CUI-Lahore Campus (IRCBM Department) and meet with (Mr. Ashfaq / Mr. Muneeb) for inspection of the Samples before quoting rates to avoid Quality and specification issues.

The bid should be submitted in a sealed and stamped envelope up to <u>September 07, 2022 before 1400 Hrs</u> and will be opened on the same date at <u>1430 Hrs</u> in the presence of available bidders. In case of any holiday is announced by the Govt. OR any unforeseeable circumstances that prevent the tender from being opened on the date announced (Force Majure Situation), the tenders will be opened on the very next working day. Timing will remain as mentioned in the tender notice.
- **13.** Any defective / sub-standard item (s) will be replaced by the bidder in same quoted cost. In case of failure to supply the specific item, CUI-Lahore may issue PO to next lowest bidder to supply the item while the difference of amount will be deducted from the 1st lowest bidder's earnest money.
