

Ms. Zainab Naveed ranked among top 100 Women of Islamic Finance Industry





- * Hopefully relevant Industries use this knowledge to produce products according to Shariah Standards.






















Webinar on "How to Improve Quality of Education in HIEs"

Objective:


Through this seminar the participants got more knowledge about giving Zakat. In order to create balance in the society and never let a poor and needy to suffer or die.

































Visit of Green Crescent Environmental Engineering Consultants (GCEEC) officials at CUI Lahore Campus




Visit to Superior University and University of the Punjab



Halal Advisory at CIF will extend services in following dimensions:






















HEC recognized COMSATS Journal of Islamic Finance (CJIF)


