- 1. The contract will be executed and handed over in satisfactory conditions up to the entire satisfaction of COMSATS Institute of Information Technology, Lahore Campus.
- 2. Terms & Conditions and BoQs should be attached with Technical and Financial bids, otherwise your tender/bid(s) may be rejected.
- Documents along with Pay Order / Demand Draft amounting <u>Rs. 500/-</u> as a tender documents fee (Non-Refundable) in favor of COMSATS Institute of Information Technology, Lahore to the address given below. No bid will be accepted without tender documents' fee.
- 4. Part / Advance payments is not allowed.
- 5. Purchase/Supply Order will be awarded on Turnkey/Grand Total basis.
- 6. The exact completion/delivery time from the date of the purchase / work order will be <u>40</u> days. The handing over / completion time for this contract is of critical importance.
- 7. Any addition, deletion or modification of any clause of the procurement terms & conditions of CIIT by any vendor will not be acceptable and may lead to rejection of the bid.
- 8. The bid proposal should be inclusive of freight and all taxes delivered at COMSATS Institute of Information Technology, Lahore Campus's premises.
- **9.** COMSATS Institute of Information Technology, Lahore Campus, will follow the PPRA rule of **single stage two envelope procedure**;
 - i. The bid shall comprise a single package containing <u>two separate envelopes</u>. Each envelope shall contain separately the <u>financial proposal</u> and the <u>technical proposal</u>;
 - ii. The envelopes shall be marked as <u>"FINANCIAL PROPOSAL"</u> and <u>"TECHNICAL PROPOSAL"</u> in bold and legible letters to avoid confusion;
 - iii. Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened;
 - iv. The envelope marked as <u>"FINANCIAL PROPOSAL"</u> shall be retained in the custody of the procuring agency without being opened;
 - v. The procuring agency shall evaluate the technical proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not conform to the specified requirements;
 - vi. During the technical evaluation no **amendments** in the technical proposal shall be permitted;

- vii. The financial proposals of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance;
- viii. After the evaluation and approval of the technical proposal the procuring agency, shall at a time within the bid validity period, publicly open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically nonresponsive shall be returned un-opened to the respective bidders;

- x. The bid found to be the lowest evaluated bid shall be accepted.
- 10. Bidders who do not qualify cannot challenge the finding of the evaluation.

- 13. The envelope shall also bear the word "CONFIDENTIAL" and following identification quotation of "Environment Monitoring System for Data Center, CIIT-Lahore".
- 14. The bid form (Annex-I) must be duly filled in, stamped and signed by the authorized representative of the bidder.
- 15. If the vendor fails to deliver the goods / services to CIIT-Lahore in time then the penalty will be charged as under:
 - **a.** 1% per day of the invoice price for 5 working days.
 - **b.** 2% per day of the invoice price for further 5 working days.
 - **c.** If the vendor fails to deliver the goods / services during the extended period then the purchase / work order may be cancelled, earnest money and payment may be forfeited.
- **16.** If the delivered goods / services are not according to the required quality standards / specifications, the same shall be liable to be rejected after inspection. The vendor would be required to supply as per requirements mentioned in our BoQs, otherwise the purchase / work order will be cancelled after due date with confiscation of earnest money.
- 17. All prices should be quoted F.O.R (Pak Rupees) inclusive of all taxes.
- 18. All prices should be valid for at least <u>90 days.</u> Withdrawal or any modification of the original offer within the validity period shall entitle CIIT to forfeit the earnest money in favor of the CIIT and / or put a ban on such vendor participation in CIIT tenders / works.
- 19. It is the sole responsibility of the agent / supplier / manufacturer to comply with the applicable laws, be national or international.
- 20. In case of any dispute, decision of the Director CIIT-Lahore, will be final and binding upon the parties.
- 21. The CIIT-Lahore reserves the right to modify the quantities at any time before the award of work.
- 22. The bidder is required to furnish in form of Bank deposit /C.D.R / Pay order equivalent to **2%** of the total Bid price as Earnest Money crossed in favor of "COMSATS Institute of
