- 3. The auction documents should be submitted up to <u>Thursday/November 28, 2024</u> on or before <u>11:00hrs</u> and the <u>open auction</u> will be held on the same date at <u>11:30hrs</u>, at COMSATS University Islamabad Lahore Campus.

Terms and Conditions of Auction

- 1. The <u>Used Examination papers</u> may be seen / visited at COMSATS University Islamabad Lahore Campus on any working day during office hours.
- 2. The minimum bid price rate is Rs.83.50/- per kg inclusive of all auction taxes
- 3. Used examination papers will be auctioned on "AS IS WHERE IS BASIS"
- 4. Your bid should be inclusive of all auction taxes.
- 5. The auctioned Items shall be handed over to the successful bidder only, after depositing of full payment.
- 6. Offer letter (s) will be awarded to the highest bidder (s) on the **basis of turnkey.**
- 7. The highest bidder will have to <u>deposit 30% amount</u> of total bid at COMSATS University Islamabad Lahore Campus HBL Branch <u>on the spot</u> by getting Challan Form from the Accounts Section and the balance amount will have to be **deposited within 03 days** on acceptance of the highest bid by the Competent authority i.e. (subject to the approval of competent authority) and then handing/taking over of the items/ materials will be done.
- 8. If the Vendor fails to deposit the remaining amount within stipulated time period as mentioned in clause # 7, his already submitted 30% amount shall be forfeited.
- 9. The successful bidder must submit an affidavit confirming that the auctioned materials will not be sold in the open market and will be exclusively used for paper recycling purposes.

- 10. All prices should be valid for at least <u>30 Days</u> withdrawal or any modification of the original offer within the validity period shall entitle CUI to forfeit the earnest money in favor of the CUI Lahore.
