- 2. Bidders are advised to submit the bid on the prescribed BoQs of COMSATS University Islamabad, Lahore Campus and clearly mention the quoted model / brands as required in the BoQs with complete terms and conditions signed, stamped, otherwise your item(s) / bid may be rejected.
- 3. <u>Multiple rates of an item may also lead to the rejection of bid / item.</u>
- 4. <u>Purchase / work order shall be awarded to successful bidder (s)on Item Wise Basis.</u>

Payment will be made on submission of Invoice in the name of "COMSATS University Islamabad, Lahore Campus" with a copy of delivery challan (s) after the complete order has been supplied, inspected and accepted which includes delivery and installation, and COMSATS Lahore acceptance / inspection thereof.
- 8. All prices should be quoted on F.O.R (Pak Rupees) and <u>valid for at least 60 days</u>.
- 9. In case of any dispute or grievance, the matter shall be addressed as per PPRA rules.
- **10.** If the vendor fails to deliver the goods / services to COMSATS University Islamabad (CUI), Lahore Campus within the given deadline, any of the following can be opted by CUI Lahore campus on the recommendation of the end user and approval of the authority;
